### **General Reports**

### • President's Report/Executive Committee

 David Snodgrass stated that the Executive Committee approved motion to allow Gassen to collect payment in regards to foreclosures.

#### Heritage Committee

Nancy Dilks reported that a few people came to the Karen House taking pics and asking to see historical docs, doing a documentary on "life in the 70's"; Jonathan fit in this criteria; Nancy & Jodi saw the documentary; Jodi will try to get the 2 minute video to play at a future board meeting.

## Architectural Review Committee

 David Snodgrass noted the new construction policy under ARC Review; will not allow Master development rights to be transferred with pieces of property. We are looking at refreshing Architectural guidelines. No new ARC violations reported.

# • Activities Committee

#### • Apartment Correspondence Committee

David Snodgrass stated there are no items of note at this time.

#### Adhoc Annual/Special Meeting Committee

David Snodgrass stated that this will be addressed later in the meeting.

### • Treasurer's Report/Finance Committee

- Mark Perry stated that the finances look good, predict that we will end strong at the end of the year, current op funds are \$135,000, cash reserves are 245,000. Continue to deposit amounts into that on a monthly basis. Income for yr. is \$18k over budget. Expenses are just under \$69,000 under budget. Legal expenses and equipment are main contributors to expenses. Total of \$87,000 "in the good."
- Our assessments did not change for 2014. Association has had 7 proposed payment settlement plans on foreclosures. We hope more seek to utilize this option.

### • Management Report

- Jodi Sondergaard provided the following updates:
  - We had a couple days at Karen house with holiday spirit and cheer; Alice, Jodi, and Gregg have put up Xmas lights, would like residents to be able to see the lights at night. Starting a recipe share plan at the Karen House-residents have come in shared recipes. Gregg has been focusing on trees and brush on trails; has provided salt to all mail stations. During the snowfall, he is going out first thing in the morning to make sure that they are clear of snow/ice. Set up a live answering service to provide live personal service for our residents 24/7/365. The service sends out messages to Jodi & Greg for \$35/month, also gives a call log/report at the end of each day. Received a removal estimate for removing the basketball court. Mark Perry "do we think it would be beneficial to put inexpensive shovels at each mail station?" Jodi will look into doing this in the near future.

Once direction is established, we will set an action plan for moving forward. Victoria Way is priority #1. Decision will 'probably' be made in January so we can be ready to go in March.

#### Asphalt Proposal

\$10,000 seems a little high...we are not under obligation to make decision tonight. Project will come out of capital expense. "did the people who estimate the value of Jonathan take into account the condition of the trails now or the future of them" (Mark Perry-paraphrased) "This probably goes in to next year's discussion for budgeting" (David) "No action required by anyone tonight" (David) "is this a spot that they will improve the way the path is? (cumbersome turn, or blacktop only) (Nancy)" If there is a better way to do it, they will do that. Nancy has been approached by a homeowner

about the trail that goes by the Karen House (by the street)-will show Jodi next time she is there.
