Call to Order

Meeting was called to order at 6:50pm, by David Snodgrass.

<u>Designate the Quorum</u>: 8 board members present; a quorum has been reached. David noted that Mark Perry will be leaving early, however quorum will be maintained at 7.

Treasurer's Report/Finance Committee

- Mark Perry provided the following highlights:
 - Operating funds were healthy at 393,000
 - Cash reserve has grown at 175,000
 - Accounts receivable is down to 252,000
 - Year to date income is at 410,000, year to date expenses are at 457,000, with a positive difference of approximately 53,000

- President's Report/Executive Committee
 - David Snodgrass stated that there were no items of note at this time
- Heritage Committee

- Architectural Review Committee
