## **Unfinished Business:**

- **A.)Bridge Resolution:** Management is waiting to hear back from the City of Chaska about how to proceed in decommissioning the bridge.
- **B.)**Strategic Marketing Plan: Scharpen looks forward to board work session on 10/15/16. He wants to set objectives; mid to long-term. He encouraged the board to consider: What is Jonathan better at than other associations? What can we do better? How can we better understand our residents? What do we know about the residents? What tools do we have at our disposal? What do we need to communicate? How do we communicate? How do we measure marketing/communication plan success? Wolff stated he would like to see a clear, concise communication plan. Board members agreed that efforts should be made to gather member email addresses.
